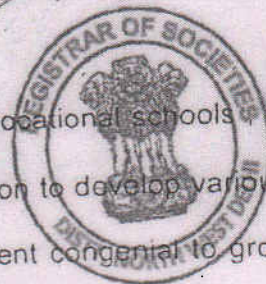
3. AIMS & OBJECTIVES:

### SECRETARY

The powers of the secretary shall be as under:-

- a) To sign on behalf of the society & to conduct its correspondence & to record the proceedings of the meeting.
- b) To summon & attend the meeting of General body
- c) To call ordinary general meeting if desired on written request of at least 3rd of total no of members.

### JOINT SECRETARY

In absence of Secretary, Joint Secretary will discharge the role & responsibilities of secretary & all the powers of secretary, in absence of president will be vested in Joint Secretary. In addition to this Joint Secretary will discharge such responsibilities / duties & will have such powers as may be defined by Governing Body.

### TREASURER

He shall keep accounts of all receipts & expenditures of the society and to furnish necessary information of the governing Body. He will keep with him up to maximum of Rs25000/- (Twenty Five Thousand) in cash and the balance account will be deposited in the bank/ post office etc. as decided by the Governing body

### 15. AUDIT:

The accounts of the society shall be audited at least once in a year by an auditor appointed by the Governing Body.

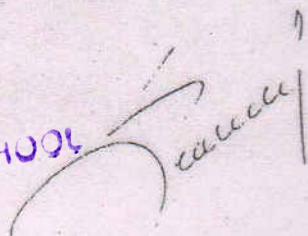

**RULES AND REGULATION OF  
BLUE MOUNTAIN EDUCATION SOCIETY**

**1. NAME:**

Name of society shall be BLUE MOUNTAIN EDUCATION SOCIETY

**2. MEMBERSHIP:**

The membership of the society is open to any person of repute and good conduct who has attained the age of majority and fulfills the terms and condition of the society without discrimination of religion, caste, color or creed but subject to the approval of the governing body. If the membership is refused to a certain person or persons, the reason for refusal shall be communicated to the person concerned.

**2 SUBSCRIPTION:**

- (i) Admission fee Rs 500.00 at the time of admission
- (ii) Subscription Rs 50.00 per month or Rs 600.00 per annum.
- (iii) Life long membership fee Rs. 5000.00

**3. TERMINATION OF MEMBERSHIP:**

The governing body shall have the power to expel a member from the society on the following terms and condition:-

- a) On his/her death or insanity
- b) Non payment of subscription continuously for than three months or year (as the case may be) from due date.
- c) On his/ her written Resignation.

d) If he or she has not attended three consecutive meetings of the general body without any information.

#### 4. APPEALS:

All appeals should be referred to governing body. The decision of the governing body shall be final. The reason for rejection shall be communicated to the person concerned.

#### 5. RE-ADMISSION:

In case of member expelled by the governing body, the same can be re-admitted provided the member pays up all the dues to the society. However, the decision of the governing body shall be final.

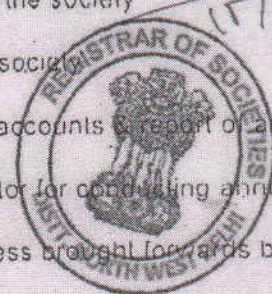
#### 6. GENERAL BODY OF THE SOCIETY:

There shall be a general body of the society consisting of all the member. The meeting of the general body shall be held at least once every year with 2/3<sup>rd</sup> quorum. No quorum shall be required in the adjourned meeting. An emergency meeting of the General Body may also be summoned on the written request of 3/4<sup>th</sup> members, with 45 days prior notice for such meetings. The notice period of the General meeting of the General Body shall be 21 days. The following business programs shall be transacted in these meetings:-

- i) To prepare annual programs and policies
- ii) To discuss and to decide all such matters and issues which are directly or indirectly related to the affairs of the society
- iii) To pass annual budget of the society
- iv) To consider & adopt audited accounts & report of auditors thereon
- v) To appoint in a qualified auditor for conducting annual audit of the society
- vi) To consider any other business brought forwards by the governing body.

#### 8. BANK ACCOUNT:

The bank account of the society shall be operated by the Chairman & Secretary or treasurer jointly with severally or as decided by the governing body. Loan for objects of the society may be raised as and when and for such amount as may be decided by governing body.

#### 9. FUNCTION OF GOVERNING BODY:

- To consider any business brought before the Governing Body.
- There shall be meeting of the Governing Body once in 3(three) months.

#### 10. SOURCE OF INCOME :

The fund of the society shall consist of

- Admission fee
- Capital Fund
- Donation and Gifts
- Subscription and Donation from members
- Aid from the Governments, semi-governmental charitable trusts, institutional and associations.
- Aid or donation or gifts from foreign charitable agencies through any other approved and authorized organizations.

### 11. GOVERNING BODY

The Governing Body's strength shall not be less than 5 (Five) & not more than 8 (Eight). The members of the Governing Body shall hold the office for 3 (three) years. The meeting of the Governing Body shall be held as & when necessary for which 2 (two) day's notice will be required and the quorum shall be 2/3<sup>rd</sup>

### 12. ELECTION AND QUORUM:

The General Body in its annual meeting will elect its chairman & all the office bearers & members in the month of September after every 3 (three) years by secret ballot. The quorum of the General Body & Governing Body shall be 2/3<sup>rd</sup>

### 13. MANAGEMENT OF FUNDS:

All income of the society shall be deposited in the designated bank. Surplus of funds if there is any may be invested, as decided by governing body, only in the manner and only in the securities specified in sec 11(5) of the Income Tax Act 1961 as amended from time to time.

### 14. POWERS AND DUTIES OF THE OFFICE BEARERS:

#### PRESIDENT

He will be the head of the society & preside over the meeting of the General Body & Governing Body. He will have the right of casting vote in the case of tie

#### VICE PRESIDENT

In absence of President, Vice President will discharge the role & responsibilities of president & all the powers of president in absence of president will be vested in Vice President. In addition to this, Vice President will discharge such responsibilities / duties & will have powers as may be defined by Governing Body.
