1. NAME :

2. REGISTERED OFFICE :

The Registered office of the society shall be situated in the national Capital Territory of Delhi, at present it is at 8/11, Vijay Nagar, New Delhi-110009. The area of operation will be all over India.

3. AIMS & OBJECTIVES:

3.1 Main object with which society is established is to promote, irrespective of cast, color and religion, without profit motive, intellectual, educational academic and social, growth, betterment and upliftment of people, specially children by providing academic / vocational / professional education, training & counseling

Any one or more of the following activity may be undertaken to attain main objects.

for providing comprehensive education to develop various facets of personality

RULES AND REGULATION OF BLUE MOUNTAIN EDUCATION SOCIETY

1.NAME:

Name of society shall be BLUE MOUNTAIN EDUCATION SOCIETY 2.MEMBERSHIP:

The membership of the society is open to any person of repute and good conduct who has attained the age of majority and fulfills the terms and condition of the society without discrimination of religion, caste, color or creed but subject to the approval of the governing body. If the membership is refused to a certain person or persons, the reason for refusal shall be communicated to the person concerned.

2 SUBSCRIPTION:

- Admission fee Rs 500.00 at the time of admission
- Subscription Rs 50.00 per month or Rs 600.00 per annum. (ii)
- Life long membership fee Rs. 5000.00

3. TERMINATION OF MEMBERSHIP

4. APPEALS:

All appeals should be referred to governing body. The decision of the governing body shall be final. The reason for rejection shall be communicated to the person concerned.

5. RE-ADMISSION:

In case of member expelled by the governing body, the same can be readmitted provided the member pays up at the dues to the society. However, the decision of the governing body shall be final.

6. GENERAL BODY OF THE SOCIETY:

There shall be a general body of the society consisting of all the member. The meeting of the general body shall be held at least once every year with 2/3" quorum. No quorum shall be required in the adjourned meeting. An efficigent meeting of the General Body may also be summoned on the written request of 3/4th members, with 45 days prior notice for such meetings. The notice period of the General meeting of the General Body shall be 21 days. The following business programs shall be transacted in these meetings:-

i) To prepare annual programs and policies

n)To discuss and to decide all such infalters and issues which are directly or indirectly related to the affairs of the society

iii)Toppas annual budget of the society

To consider & adopt audited accounts report of auditors thereon

11.GOVERNING BODY

The Governing Body's strength shall not be less than 5(Five) & not more than 8(Eight). The members of the Governing Body shall hold the office for 3 (three) years. The meeting of the Governing Body shall be held as & when necessary for which 2 (two)day's notice will be required and the quorum shall be 2000 12.ELECTION AND QUORUM:

The General Body in it's annual meeting will elect it's chairman & all the office bearers & members in the month of September after every 3 (three) years by secret ballot. The quorum of the General Body & Governing Body shall be 2/3" 13.MANAGEMENT OF FUNDS:

All income of the society shall be deposited in the designated bank. Surplus of funds if there is any may be invested, as decided by governing body, only in the manner and only in the securities specified in sec 11(5) of the Income Tax Act 1961 as amended from time to time
